This certificate will remain in effect until withdrawn by the purchaser, or the purchaser's sales tax account is closed, or the purchaser's ability to make tax-free purchases is amended or revoked by the Lafayette Parish School Board Sales Tax Division.

SALES & USE TAX EXEMPTION CERTIFICATE INSTRUCTIONS

Use this form to claim exemption from sales and use tax on purchases of taxable items. The purchaser must complete all fields on the exemption certificate and provide the fully completed certificate to the seller in order to claim exemption.

Purchaser: You are responsible for ensuring that you are entitled to the exemption you are claiming. It is your responsibility to inform the seller if any part of the information is variable. You will be held liable for any tax and interest, as well as penalties imposed by Lafayette Parish School Board Sales Tax Division, if you are not eligible to claim this exemption.

Seller: You are required to keep a copy of this exemption certificate in your files and provide information on the purchaser to any local taxing jurisdiction upon request. You are relieved of the responsibility for collecting and remitting sales tax on the sale or sales described on the exemption certificate, provided all of the following conditions are met:

1. all fields on the exemption certificate are completed by the purchaser;
2. the fully completed exemption certificate is provided to you at the time of the sale; and
3. you do not fraudulently fail to collect the tax due or solicit customers to unlawfully claim an exemption.

This exemption applies to the local sales tax only and cannot be used to exempt the State of Louisiana sales tax. A separate state sales tax exemption is required.
